#### Guidelines for writing papers

- MS Word compatible;
- Page setup: A4, 2.5 cm margins, single column;
- Font: Calibri, 12 pt, except the title in 14 pt, single spaced;
- The title and all subtitles should be capitalized and bold;
- Abstracts should be no longer than 250 words and end with 3-5 key words;
- Articles should begin with the name of the author, the institution and its address;
- Articles should have the following sections: Introduction, Research Methodology, Results and Analysis, Conclusions, and Bibliography;
- Size: No more than eight pages;
- Articles should be written in one of the working languages with abstract in English;
- Authors can submit and publish more than one article, but present only one;
- Harvard citation style
- The deadline to submit articles is October 10, 2018;
